Policies and Additional Information

PAYMENTS, PENALTIES AND REFUNDS

Enrolment in any class is held for the full 28-week (9 month) program from September 2021 - May 2022 and classes will be closed for registration after January 30th. Payments for all fees are fully non-refundable and non-transferable, except as outlined in this Fees Schedule, the Comp. Fees Schedule and in the Policies & Waiver & Release. Students may transfer to an alternative class after registration has been processed, depending on availability. **Transfers will be charged the administrative CLASS TRANSFER FEE of \$20.00 +HST/ class.**

[Please NOTE: There are no class transfers permitted after January 30th.]

LATE PAYMENTS

Late payments will be invoiced an additional fee of \$45.00+HST regarding non-payments if payment is received after the scheduled due date, after 2 written warnings. A credit card number must be provided at the time of registration; however, the credit card will not be charged provided that payment in the form of a Cheque or Debit is received prior the due date indicated on our Fee Schedule, following the aforementioned written warnings.

WITHDRAWAL POLICY

Should a student wish to withdraw from a class, written notice must be provided to Jennifer Buckton, General Manager, Turning Pointe Academy of Dance Ltd. In order to avoid payment upon withdrawal from a class, written notice must be provided *prior to the commencement of Term 2, 3 or 4* and may be provided in person to the Reception desk during business hours or forwarded via email to admin@turningpointe.ca. Until such notice is received, a space will be held for that student in their class and all fees and other charges as invoiced will be due when scheduled and payment will be processed to the credit card on file.

***Please NOTE:**

*TPA programming is based on a full year enrolment. With new government restrictions and limited capacity for class enrolment, we must ask that placements in classes are reserved for the entire season. Therefore, in the event of a withdrawal, **an additional WITHDRAWAL FEE of \$50.00***

(+HST)/class will be charged upon notice of removal from any or all programming at Turning Pointe Academy at any time. *Although we understand that withdrawals are sometimes required by families for various reasons – this decision does have an effect on the integrity of our programming as a whole. We must consider class minimums, the length of a class scheduled and planning for our year end recital; therefore, as the registration process is reflective of a full season, this administration charge is necessary to assist with the fees lost in part due to the withdrawal.*
